#### 4. FIRST AID MEASURES

If poisoning occurs, contact a doctor or Poisons Information Centre (Phone Australia 131 126, New Zealand 0800 764 766).

**Inhalation:** Remove person from exposure - avoid becoming a casualty. Remove contaminated clothing and loosen remaining clothing. Allow person to assume most comfortable position and keep warm. Keep at rest until fully recovered. Seek medical advice if effects persist.

**Skin Contact:** If skin or hair contact occurs, immediately remove contaminated clothing and flush skin and hair with running water. Continue flushing with water until advised to stop by the Poisons Information Centre or a doctor; or for 15 minutes and transport to doctor or hospital.

**Eye contact:** Immediately irrigate with copious quantities of water for 15 minutes. Eyelids to be held open. Remove clothing if contaminated and wash skin. Urgently seek medical assistance. Transport to hospital or medical centre.

**Ingestion:** Rinse mouth with water. If swallowed, do NOT induce vomiting. Give a glass of water to drink. Never give anything by the mouth to an unconscious person. If vomiting occurs give further water. Seek medical advice.

## 5. FIRE FIGHTING MEASURES

**Suitable extinguishing media:** If material is involved in a fire use water spray or fog, foam, dry chemical powder or carbon dioxide.

**Specific hazards:** Non-combustible material, however following evaporation of aqueous component residual material can burn if ignited. Containers may explode on heating. Upon burning may emit acrid smoke and corrosive fumes.

## **6. ACCIDENTAL RELEASE MEASURES**

#### **SMALL SPILLS**

Clean up spill immediately. Wear protective equipment to prevent skin and eye contamination. Avoid inhalation of vapours or dust (from dried product). Wipe up with absorbent (clean rag or paper towels). Collect and seal in properly labelled containers or drums for disposal.

#### **LARGE SPILLS**

Clear area of all unprotected personnel. Slippery when spilt. Avoid accidents, clean up immediately. Wear protective equipment to prevent skin and eye contamination and the inhalation of vapours. Work up wind or increase ventilation. Contain - prevent run off into drains and waterways. Use absorbent (soil, sand or other inert material). Collect and seal in properly labelled containers or drums for disposal. Dispose of waste according to the applicable local and national regulations. If contamination of crops, sewers or waterways has occurred advise local emergency services. Launder all protective equipment prior to reuse.

## 7. HANDLING AND STORAGE

**Handling:** Avoid eye contact and skin contact. Avoid inhalation of vapour, mist or aerosols. Wear protective clothing when risk of exposure occurs. Avoid contact with incompatible materials. When handling, DO NOT eat, drink or smoke. Keep containers closed at all times. Avoid physical damage to containers. Always wash hands with soap and water after handling. Work clothes should be laundered prior to reuse.

## 11. TOXICOLOGICAL INFORMATION
