**Emergency Procedures** 

Minor spills do not normally need any special clean-up measures – rinse with water.

In the event of a major spill, prevent spillage from entering drains or water courses. Wear appropriate personal protective equipment and clothing to prevent exposure. Increase ventilation. As a water based product, if spilt on electrical equipment the product will cause short-circuits. If possible contain the spill. Place inert absorbent material onto spillage.
